Finalists check in time will be at 5:00pm behind the Kessler's Big Top Tent.

## Information & Entry Rules

**Final Competition:** Wednesday, August 16<sup>th</sup>, 2017 – 6:00 to 7:30pm at the Brown County Fair

Aberdeen FCU will award prizes as follows: 1<sup>st</sup> Place - \$1,000; 2<sup>nd</sup> Place - \$750; 3<sup>rd</sup> Place - \$500

Youth Category (Ages 13 & under): 1<sup>st</sup> Place - \$250; 2<sup>nd</sup> Place \$100

The competition is free and open to all ages and amateur entertainers. Contestants must be strictly amateur. An unpaid instructor is considered an amateur. Persons reimbursed on a regular basis for their performance are not considered amateurs and are not allowed.

All acts shall be suitable for "family entertainment". Acts containing vulgar components will be disqualified and removed from the stage.

If an act contains animals, they shall be controlled.

Judges decisions based on: stage presence, quality of performance, talent, choice of selection and entertainment value. **Judges decisions are final.**

Each act shall be allowed up to 4 ½ minutes of performance time. Acts running longer than 4 ½ minutes shall receive a deduction of points by the judges. *Initial here* \_\_\_\_\_

Acts may be individual, duet or a group. Anticipation of the size of the stage (approximate 60' by 14') should be considered when composing a group act.

All finalist shall use the sound system provided for the venue. Vocalists may use recorded accompaniment. Finalist using background music must submit their audio in a format selected by the venue to [RisingStar@AberdeenFCU.org](mailto:RisingStar@AberdeenFCU.org) by Monday, August 7<sup>th</sup>, 2017. *Initial here* \_\_\_\_\_

To preserve impartiality, no relatives or employees of Aberdeen Federal Credit Union, Aberdeen Federal Credit Union Board, Brown County Fair, or Brown County Fair Board shall be allowed to compete.

All acts will be pre-screened and finalists **must perform the same act or musical selection** as used for their original submission. Finalists will be disqualified if the act is changed. *Initial here* \_\_\_\_\_

Acts selected as finalists will be notified by Thursday, August 3<sup>rd</sup> and will be invited to perform at the Brown County Fair on Wednesday, August 16<sup>th</sup>, 2017 from 6-7:30pm. Finalists check in time will be at 5:00pm backstage at the Kessler's Tent. All finalist **must be** checked in by 5:30pm. *Initial here* \_\_\_\_\_
